



## Healthcare Program Options in California

### Information Current as of August 12, 2009



Many families with children who are eligible for the Healthy Families Program but unable to enroll due to the current wait list can access health care through other programs. Use this matrix to help identify the appropriate program for the families you assist.

Program	Status	Action Needed	Other Information
<b>Medi-Cal</b> <i>(i.e. Share of Cost, Minor Cont, Emergency or Restricted/Limited-scope)</i>	<b>OPEN</b>	Submit application using mail-in, Health-e-App or One-e-App (where applicable)	Families with a Share of Cost should notify their worker if their income drops to lower their share of cost
<b>Healthy Families</b>	<b>CLOSED</b> to new enrollment <b>WAIT LIST</b> available	→ If a child is not enrolled, <b>submit application</b> using mail-in, Health-e-App or One-e-App (where applicable) to get child on the wait list → If a child is currently enrolled, inform families to pay premiums on time and complete the Annual Eligibility Review on time so they are not dropped from the program and put on the wait list	→ Babies born to mothers on AIM will still be enrolled in Healthy Families → Families currently engaged in the Appeals Process will stay enrolled → Families with a child already enrolled and need to add a child should submit the Add-A-Person Form to add the new child to the wait list

<b>Family PACT</b>	<b>OPEN</b>	Refer a family to a Family PACT provider
