- Joe Rogoff: Guerneville Rep, chairs the communications committee and is on the land use committee. Interests include advancing workforce housing, protecting the environment, and securing fair county resources for Guerneville and the Lower Russian River.
- Spencer Scott Guerneville Rep: Prioritizes the long-term wealth and health of the community.
- Lonnie Lazar: New Rep from Forestville: Has lived in Forestville for about 1.5 years. Intent on preserving the environment and the unique community feeling of the lower Russian River area.
- Thai Hilton, New Rep from Forestville: Resident since 2017, interested in representing Forestville at the county level and ensuring local concerns are addressed.
- Vicki Clewes, Hacienda: Second year of the first term. Engaged in understanding and helping to resolve community issues.
- Pip Marquez de La Plata: Long-term member of the MAC, focused on bringing attention and resources to Rio Nido, a community often overlooked.
- Betsy Van Dyke: Guerneville South / Pocket Canyon: aims to voice concerns of lessrecognized communities. Involved in community organizations since 1987.
- Cynthia Striker, Rep from Monte Rio Villa Grande: 46-year resident, liaises with the citizens' advisory group in Monte Rio, focusing on wastewater, workforce housing, the environment, and fire protection.
- Mike Nicholls: Rep from Duncans Mills / Cazadero. Sixth year on the MAC, involved in rural broadband expansion, fire protection, and has a background in the food industry.
- Kathy Dahl, Guerneville Alternate: Long-term community representative, focusing on the wellbeing of Gville.
- Patty Thayer Alternate for Villa Grande / Monte Rio: Second year as an alternate, involved in land use, communications, and land acknowledgment committees. Interests align with community housing, the environment, and climate change.
- Jenn Otten, Rio Nido Alternate: Manages the Russian River Resource Facebook page, aims to contribute to community groups and initiatives.
- Brian Andriola, Hacienda Alternate: Focused on community resiliency, fire protection, communication, public infrastructure, and general community resiliency.

The Land Use CommiFee held a joint mee=ng with the Lower Russian River MAC on February 1,2024. The agenda included Major Land Use Project Process and Steps for Public Input. Hos=ng Deputy Director of Permit Sonoma, ScoF Orr. AFendees included Planning Commissioners Koenigshofer and Marquez and MAC Members ScoF and Strecker. The agenda also included the Sub-CommiFee's Organiza=on and Mee=ng Calendar for 2024.

#### Agenda Item 3

Deputy Director Orr reviewed Ministerial, Discre=onary and Land Use permiWng in detail. It was noted by commiFee members and by public input, that permiWng is a complex subject and challenging for cons=tuents to follow. Mr. Orr shared that Permit Sonoma had iden=fied this issue and a new employee will be charged with upda=ng websites and outreach into a format understood by the lay person. It was urged from public comment, that a glossary of terms also be included on outreach by Permit Sonoma. CommiFee members were gra=fied to be updated on the streamlining process undertaken by Permit Sonoma at the request from the County Board of Supervisors. The mee=ng minutes will include the specific examples Mr. Orr presented on each type of permit.

#### Agenda Item 4

Chair Nicholls stated that succession is important on public commiFees and recommended that a new chair be appointed for 2024. Member Thayer indicated she would volunteer for the chair posi=on for 2024 if Nicholls would remain on the commiFee. Member Rogoff stated his interest on remaining on the commiFee. Member Hernandez has resigned from the commiFee and Nick Schwanz, co-owner of Solarpunk Farms in Guerneville volunteered for the community member posi=on on the CommiFee. We will require the full MAC Council to confirm the exis=ng members, appoint a new MAC representa=ve to the commiFee and confirm Mr. Schwanz as the community member to the board.
