

PRE-ADOPTION SUMMARY OF A PROPOSED ORDINANCE

Summary of a Proposed Ordinance of the Board of Supervisors, County of Sonoma, State of California, Adopting Revised Supervisorial District Boundaries for All of the Supervisorial Districts of the County, Repealing Sonoma County Code Section 1-8, and Directing County Staff to Maintain for At Least 10 Years the County's Redistricting Website to Continue to Inform the Public About the Redistricting Process and the Revised Boundaries.

On December 7, 2021, the Board of Supervisors of the County of Sonoma will conduct a public hearing to consider adoption of a proposed ordinance entitled, "An Ordinance of the Board of Supervisors of the County of Sonoma, State of California, Adopting Revised Supervisorial District Boundaries for All of the Supervisorial District so the County, Repealing Sonoma County Code Section 1-8, and Directing County Staff to Maintain for At Least 10 Years the County's Redistricting Website to Continue to Inform the Public About the Redistricting Process and the Revised Boundaries ("Ordinance").

Redistricting Process and the Revised Boundaries ("Ordinance").

Every 10 years, local governments use data from the federal census to redraw their district lines to reflect how local populations have changed. Redistricting determines which neighborhoods and communities are grouped together into a district for purposes of electing members to the Sonoma County Board of Supervisors. Community participation is strongly encouraged to ensure that district lines respect, to the extent practicable, the following qualities: geographic contiguity, minimal division of neighborhoods and other communities of interest; minimal division of cities; geographical boundaries; and geographic compactness. The proposed Ordinance would modify the supervisorial districts in the County of Sonoma following the release of the 2020 federal census data in compliance with the United States Constitution, the California Constitution, the federal Voting Rights Act of 1965 (52 U.S.C. Section 19301 et seq.), and the California Fair Maps Act (Elections Code Section 1-8 which described the previous Sonoma County supervisorial district boundaries. The proposed Ordinance also directs staff, in compliance with Elections Code Section 21500 et seq.). The proposed Ordinance also directs staff, in compliance with Elections Code Section 21500(g), to maintain the County of Sonoma's Redistricting website at https://sonomacounty.ca.gov/CAO/Policy-Grants-and-Special-Projects/2021-Redistricting/ for at least 10 years after the adoption of new supervisorial district boundaries.

The December 7, 2021 public hearing will be facilitated virtually through Zoom. Members of the public can watch or listen to the meetings by joining the meeting on computer, tablet or by phone. Meeting details will be posted on the County's Board of Supervisors meeting website at https://sonoma-county.legistar.com/Calendar.aspx.

Members of the public are encouraged to attend virtually but may attend in person with modified protocols. Seating will not be available in the Board Chambers for public participants. Members of the public may listen to the Board meeting in the Administration Building Hall or outside the main entrance located at 575 Administration Drive, Santa Rosa, 95403. Limited socially-distanced seats will be available in the building hall and outdoors.

Spanish language interpretation will be available. Requests for interpretation in additional languages or for disability-related modification or accommodation may be arranged by emailing a request to redistricting2021@sonoma-county. org at least 72 hours prior to the meeting.

Public comments may be made live during the meeting by joining the Zoom meeting using one of the methods above. ALL INTERESTED PERSONS ARE INVITED TO BE HEARD ON THESE MATTERS.
