## FSP CLIENT SERVICES (FSP) CODING

Full Service Partnership (FSP) programs provide a full spectrum of services to clients who require intensive treatment and meet certain eligibility requirements. Based on the philosophy of "Whatever it takes," FSPs provide mental health services, medication support, case management, and other supportive activities to meet clients' mental health, medical, housing, recreational, vocational, and educational needs.

The vast majority of clinical services provided through FSP programs are Medi-Cal reimbursable as specialty mental health services. Some services, however, may meet the FSP program-model guidelines for keeping clients engaged in services and their basic needs met, but not qualify as Medi-Cal reimbursable specialty mental health services. The Mental Health Services Act (MHSA) provides extra funding to FSP programs to cover such services.

Starting July 1, 2020, the "FSP Client Services (FSP)" procedure code allows clinicians to document such services. To be coded as "FSP Client Services," services must be linked to stabilizing the client's mental health, even if they do not qualify as reimbursable specialty mental health services.

## Please note:

- Any service that can be claimed as a medically necessary specialty mental health service should be claimed using the appropriate Medi-Cal reimbursable procedure code. "FSP Client Services" should be used **only** as a "code of last resort" when providing necessary but non-claimable outreach, engagement, and resource services to promote the client's well-being and mental health.
- Think about the clinical service you are providing, rather than the setting. You can provide Medi-Cal reimbursable rehabilitation services in the grocery store, in a car, in a waiting room, etc. Use time spent with your client to work on skill-building, rather than simply running errands for or with your client, whenever possible.

"FSP Client Services" progress notes must be written in PIRPL format.
