- WHAT: Request for a five-year Conditional Use Permit for 38,484 square feet of outdoor cultivation, 1,547 square feet of indoor cultivation, 1,414 square feet of indoor propagation and, 504 square feet of associated processing of commercial cannabis. The project will have three full-time employees. The hours of operation would be 6:00 am to 8:00 pm, seven days a week. Shipping and delivery activities are from 8:00 am to 5:00 pm. There would be no public access. The project is on a 10-acre parcel located at 885 Montgomery Road in Sebastopol, CA 95472, **APN 077-130-095. Supervisorial District 5.**

Parcel Zoning: Diverse Agriculture, Combining District B6 and Riparian Corridor 100/50.

The Sonoma County Board of Supervisors will hold a virtual public hearing to consider adopting a Mitigated Negative Declaration and an action approving an outdoor cannabis cultivation Use Permit in which all interested persons are invited to attend and provide comments. Members of the Public May Not Attend this Meeting in Person.

An Initial Study was prepared pursuant to the California Environmental Quality Act, and the project's potential environmental impacts have been analyzed. A Mitigated Negative Declaration is proposed which finds that potential environmental impacts have been fully mitigated to less-than-significant levels. All mitigation measures have been incorporated into the project conditions of approval.
